## Terms of Enrollment

1. The camp fee will be refunded upon written request prior to April 20<sup>th</sup> less your deposit. In the event that your child fails to adjust within the first week of the program, the camp or the parent may terminate the child's enrollment. A refund will be made on a prorated basis less 25% when program has been paid in full. Deposit is non-refundable. If your child does not attend the whole first week of their program, a refund will be made on a prorated basis less 50% and less the deposit.

2. The camp fee (less the \$300 deposit) is payable in 3 equal payments due February, March & May. If you register after December, the balance is payable in payments to be determined. All final camp payments must be received by May 15<sup>th</sup>.

3. All requests for any program change must be received in writing. There will be a \$25 fee after the second change in your child's program. To make any changes to your child's program after the first day of camp please email or call the office for the balance due.

4. I understand that my child has a set schedule and that if a special event or trip is planned on a day or week that my child does not attend camp I cannot change or substitute their days or weeks.

5. No refunds shall be made for camp closings, due to circumstances beyond our control, acts of God, inclement weather, sickness or absences. Missed days cannot be made up.

6. Permission is hereby granted to provide medical attention for my child(ren) in case of an emergency at the Northwell Syosset Hospital when my children's physician or I cannot be reached.

7. In the event that photographs/video are taken of your child, I hereby grant permission to the Greentrees Country Day School and Camp to use these photographs/video for current and future promotional purposes such as print advertising, brochures, social networking and more.

8. In the event that I have asked you to provide my child(ren) with transportation, I agree to accept Huntington Coach transportation for this purpose.

9. I agree to have my child participate in the swimming program provided at Greentrees Country Day School and Camp under the direct supervision of an American Red Cross Certified Lifeguard and Water Safety Instructor.

10. By signing this application I am giving permission for my child to carry sunscreen for a Greentrees staff member to apply to my child. Please label bottle.

11. Greentrees reserves the right to decline any application. The Greentrees reserves the right to terminate this agreement at the discretion of the directors.

12. I agree that any dispute concerning, relating, arising out of or referring to the subject matter of this contract shall be resolved exclusively by binding arbitration in Nassau County, New York according to the then existing commercial rules of the American Arbitration Association and the substantive laws of New York State.

13. I understand that part of the camping experience involves activities and group interactions that may be new to my child and that they come with uncertainties beyond what my child may be used to dealing with at home. Such risks include uneven terrain, standing water, and areas that may result in encounters including insects that could result in infections and various insect-transmitted diseases. I am also aware that there are certain unavoidable risks associated with various games and play activities such as collisions, wayward objects such as balls and other equipment and other risks. I am aware of these risks, and I am assuming them on behalf of my child. I realize that no environment is risk-free, and so I have instructed my child on the importance of abiding by the camp's rules and will obey them.
